

# Privacy Policy

## **Privacy of Personally Identifiable Information**

LEO Pharma Inc. (“LEO Pharma”) respects the privacy of visitors to the [www.taclonex.com](http://www.taclonex.com) website (the “Website”) and acknowledges that information about you, your health, and your health care is sensitive. The term “personally identifiable information” and “personal information” refers to information from which you can be identified and includes your name, address, telephone number, or e-mail address.

The purpose of this Privacy Policy is to inform you how we may use personally identifiable information or personal information collected from you when you visit the Website and the choices you have regarding our use of, and your ability to review and correct, the information collected.

## **Consent**

Use of this Website constitutes consent to data collection and use as described in this Privacy Policy.

## **Collection of Data**

There may be times when we ask you to provide certain personal information about yourself, such as your name, address, telephone number, e-mail address, etc. We collect only the personal information that you provide to us; therefore, in these situations, you may choose to withhold any personal data requested. If you choose not to provide the information we request, you may be unable to access certain services, offers, and content on this Website.

The Website may use a technology known as “cookies”. The Website supplies your browser with cookies, or tokens of information that contain a unique identifier and are used for a variety of purposes, including remembering log-in information and providing functionality to the Website. The cookies sent by the Website are used only by the Website and are not used to collect personally identifiable information without your permission. If you choose to furnish this Website with personally identifiable information (such as your e-mail address), that information could be linked to the data stored in the cookie. We reserve the right to change our use of cookies and our practices regarding linkage to personally identifiable information without prior notification.

The Website also uses Internet Protocol (IP) Addresses. LEO Pharma may use your IP Address to report aggregate information on use and to help improve the Website. Generally, your IP Address is not linked with any

LEO Pharma will not treat as confidential any information that you provide that is not personal or is not associated with any personally identifiable data, such as questions, comments, or suggestions. LEO Pharma or another member of the LEO Group shall be free to disclose and use this non-confidential information for any purpose, without any obligation whatsoever to you.

### **Protection of Children**

LEO Pharma is committed to protecting the privacy of children. The Website does not intend to collect personally identifiable information from children under 13 years old without the explicit consent of a parent or guardian.
